Pursuant to due notice thereof, a regular meeting of the Board of Trustees of Tri-County Electric Cooperative, Inc. (hereinafter called the "Cooperative") was held on January 23, 2025 in the Boardroom at the Headquarters Office in St. Matthews, South Carolina.

Lowder, CEO, John Felder, General Council, Frank Furtick, VP of Operations and Engineering, Tina Turnage, VP of Finance, Kristen Zeigler, VP of Human Resources, Wilford Thompson, VP of Member Services, Keith Scharf, VP of Safety and Loss Control, and Executive Assistant, Cindy Sarratt, who recorded the minutes of the meeting.

CALL TO ORDER – INVOCATION

Mr. Lowder announced that Keith Scharf has completed all his prerequisites and is now recognized by NRECA and NUTSEA as a Certified Loss Control Professional for the Cooperative.
